- Please send in the proxy, even if you plan on attending the meeting so that we can meet the quorum requirements prior to the meeting. It can be mailed or hand delivered, either by you or your proxy. It is encouraged that the proxy be submitted before the meeting in order to avoid delay in registration. Please send your proxy.
- If you appoint a proxy and later decide you will be able to attend the meeting in person, you may withdraw your proxy when you register at the meeting.
- A proxy may be revoked in writing or superseded by a later proxy to another person. It may also be assigned (substituted) by the person designated on the proxy to a third person if the person you designated as proxy decides that he or she will be unable to attend the meeting.

Please note, included in the proxy is a question for homeowners to vote on the number of members on the Board of Directors There are currently 5 members on the board.

The Notice of Intents must be received in our office by Monday, November 6, 2023.
